# A. Supplemental Notice of Imposition of Special Assessments

Ms. Mackie stated, following approval/adoption of the Delegated Award Resolution, Staff anticipates closing on the bond issuance on Friday. She presented Resolution 2024-01, which accomplishes the following:

- Brings the bond terms down from the prior resolution adopted by the Board, which imposed a master assessment lien. Staff is conforming the assessments that will actually be certified for collection against benefitting property in the CDD to the terms of the bonds.
- Includes a final Engineer's Report and final Supplemental Assessment Methodology and the bond terms and installment payments.

obligation of the Developer to complete the project, as described in the Capital Improvement Plan (CIP) to the extent that bond funds are totally expended.

On MOTION by Mr. Boos and seconded by Mr. Gelbert, with all in favor, the Completion Agreement By and Between the District and Boos-Woodsdale, LLC, related to the 2023 Bonds, was approved.
